Notes on Profit & Loss

The Financial Report reflects operations for the period1 July 2023 to 30 June 2024

FY 2023/2024 operations resulted in a Net Profit of \$29,253 which was an increase compared to FY 2022/23 \$2,287

Income

- Income of \$69,730 was received for the financial year from a combination of funding streams, including Grants, Donations and Fundraising Events (eg Auctions etc)
- Other Income of \$1,194 was received for the insurance claim payout

Cost of Sales

• Cost of Sales (Initiatives/Programs) of \$34,348 reflected the cost of purchases for goods/products for initiatives to the financial year.

Note: Some funded initiatives continue to operate beyond the financial year which have not been accrued in these figures.

Gross Profit

• Gross Profit of \$35,382 - before operating expenses

 Expenses from operations \$7,322 associated with annual insurances, facility rental, subscriptions and IT costs, and other general expenses were incurred.
