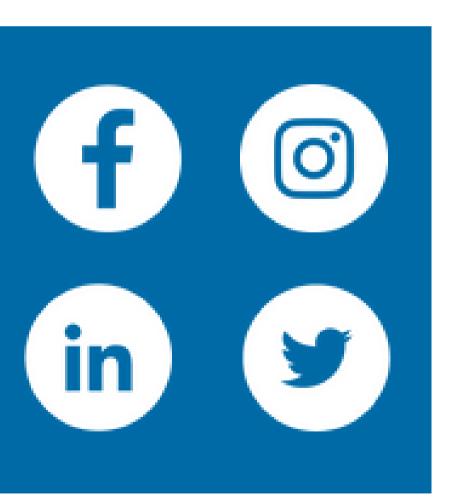




BCER's built upon it's existing operational footprint and grew it's support into four LGA's along the **Bayside area in 21/22**

Introduction

• Financial Report reflects operations for the period 1 July 2021 to 30 June 2022

• Income of \$70,819 was received for the financial year from a combination of funding streams, including Grants, Donations and Fundraising Events (e.g. auctions, etc)

• Cost of Sales (Initiatives/Programs) of \$16,412 reflected the cost of purchases for goods/products for initiatives to FYE. Note: Some funded initiatives continue to operate beyond the FYE which have not been accrued in these figures.

Net Profit

• FYE 2021/22 operations resulted in an increase in Net Profit compared to 2020/21 (\$20,410).



Operating Expenses

• Expenses from operations \$13,664 associated with annual nsurances, facility rental, subscriptions and IT costs, other general expenses were incurred. A one off donation expense was incurred to reflect the donation from a shared initiative with Rotary Club for which BCER managed the donation inflows.

• A Net Profit after operating expenses was \$40,743.

FYE 2021/22 operations resulted in an increase in Total Equity (Cash) to \$61,153 (FYE 20/21 \$20,410)

Several funded initiatives continue into 22/23 for which expenditure will be offset from the Cash assets.

A reduction in operating expenses is forecast for 22/23 from the relocation to the Moorleigh facility.

Assuming forecast operating expenses for 22/23 being less and sales not exceeding income for the funded initiatives/programs, then the overall financial position of BCER provides for continued operations for 2022/23 and 2023/24.

Proposed Resolution #1 - Refer AGM-22-003 BCER Board and Committee Meeting Structure and Frequency

BCER Constitution

- Section 58 Committee Meetings requires the Committee to meet at least 4 times in each year. ۲
- Section 63 Quorum requires committee meetings to have in attendance a majority of Committee ۲ members holding office.
- Section 56 Vacation of Office identifies that a person ceases to be a committee member if they ۲ cease to be a committee member or fail to attend 3 consecutive Committee Meetings.

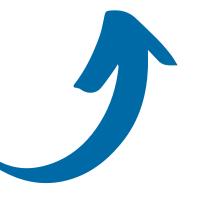
